

# AGM 2024 notice, call for nominations and nomination form

The Co-op's 2024 AGM will be held on June 20, 2024 10:00am – Noon (Pacific Time) for the purpose of:

- Receiving the audited financial statements for the previous year, for information;
- Receiving the report of the Board of Directors, for information;
- Appointment of auditors for FY 2024-25;
- Election of directors;
- Such other business as may, by virtue of the *Cooperative Association Act (BC)*, or pursuant to the Co-op's foundational documents, be properly brought before the meeting.

## Where?

Once again, this year's AGM will be exclusively via video conference. Details will be shared with registrants closer to the date. Member Delegates and/or Alternates must be registered with the Cooperative at least 30 days in advance of the AGM in order to vote.

#### What's involved?

BCLC Directors are volunteers elected by the membership. Board meetings occur approximately 6 times per year, for the most part by videoconference. In the past, the Board has met in person in Vancouver once or twice a year, with travel expenses paid by the Co-op. During the pandemic, we suspended in-person meetings and are continuing to meet exclusively via videoconference for the near future. Expect a time commitment averaging from four to six hours per month, depending on sub-committee participation.

Unlike a library board, the Cooperative board necessarily governs in a broader context, and is governed by different legislation. The Cooperative is an organization with national scope, and its partnerships and initiatives are reflective of its mandate.

# Nomination Rules:

- Any member delegate of the Co-op may nominate a candidate for Director.
- Any member delegate may be nominated for a position as a Board Director.
- Nominations may be emailed to the Nominations Committee by 1:00pm Pacific on May 16, 2024

Candidates should forward the completed the accompanying nomination form along with a photo and short biography of the nominee, including the nominee's qualifications and interest in serving on the BC Libraries Cooperative Board. The bio and photo will be posted to the BC Libraries Cooperative website prior to the AGM. Nominations from the floor are not permitted.

### Nominee Minimum Qualifications:

To qualify for nomination or appointment as a BC Libraries Cooperative Board Director, an individual must, at a minimum:

- Be a member of, or be endorsed by, their organization's senior management team or its equivalent. Rationale: The Co-op's membership consists of organizations, not individuals.
- Have demonstrated and significant experience contributing to the advancement of a Board of Governance. Rationale: The Cooperative's membership demands effective governance.
- Agree to act honestly and in good faith with a view to the best interests of the Cooperative.
  Rationale: Per the <u>Cooperative Association Act</u> S.84(1)(a).

### Voting Procedure:

All votes on elections are conducted via secret electronic vote prior to the AGM. Ballots will be sent via email to the registered, designated employee (Delegate or Alternate) of each member organization. All votes on elections are by simple majority and each member organization has one vote. Only a registered, designated employee of a member organization (Delegate or Alternate) may vote; Member Delegates and/or Alternates must be registered with the Cooperative at least 30 days in advance of the AGM in order to vote.

In the event that only one nomination is received for a position, that individual shall be declared elected by acclamation. Election results will be announced at the Annual General Meeting.

#### When are Elections Held?

Elections are held via secret electronic ballot prior to the BC Libraries Cooperative Annual General Meeting on June 20, 2024. Candidates do not need to be present at the AGM to run for office.

#### 2024 BCI C Board Nominations Form
